74. The proposal in this file relates to implementation of Puducherry Human Immunodeficiency Virus and Acquired Immune Deficiency Syndrome (Ombudsman and Legal Proceedings) Rules, 2020 in the Union Territory of Puducherry.

75. Notings of Health Secretariat at para.68-72/nf., may please be perused.

76. In this connection it is stated that based on the communication dt. 22-5-2018 earmarked to the Chief Secretary, Puducherry and Project Director, PACS (Pondicherry Aids Control Society) from the Additional Secretary & Director General, National AIDS Control Organisation (NACO), New Delhi regarding formulation of the State Rules under Section 49 of HIV/AIDS (Prevention and Control) Act, 2017, it is proposed to formulate "The Puducherry Human Immunodeficiency virus and acquired immune deficiency syndrome (Ombudsman & Legal proceedings) Rules, 2020". For which a draft has been prepared and submitted to Law Department for vetting. While vetting, the Law Department has suggested some alternations and instructed the Department to obtain the concurrence of Finance Department as financial implication involved in this regard.

77. In this regard, the proposal for Finance Department concurrence placed at Flag 73/C may please be seen, in which it is stated that the approximate annual financial implication involved in this purpose is about ₹.4,10,000/-. But, the Head of Account in which the above financial implication is going to be met out/has not been furnished in the notings of the PACS as well as in the notings of Health Secretariat.

78. Hence, at the first instance the Department may include the Head of Account in the proposal placed at Flag 73/C.

79. With the above, the file may be returned. Before return it may be submitted to Secretary (Finance) for perusal please.
